OPENING REMARKS

Ukraine is almost the only state that during several years demonstrates a positive trend. It aims to build sustainable democratic institutions and generally is guided by European standards. Success on this path is important not only for Ukraine. It, of course, will have an impact on the entire region where freedom in some places shrinks to a size of a prison cell. It requires fair and responsible treating the challenges because of which we falter on this way

The first challenge is the reforms. After Revolution of Dignity the country failed to restart the political system and the change of elites. Government sees reform more as a change of procedures within the corporations and installing a new accountability, but not as the systemic change of practice and approaches to work. As the consequence, conduction of a successful reform of the patrol service is not synced with the other structural units of the police. Reform of the judicial system just started, and that what we have at this time is rather its imitation. The pace of the reform is gradually decreasing, and in some areas,

for example, in the public prosecution office, there is observed the reverse process.

The second challenge is the war. In response to the Russian armed aggression the Ukrainian authorities resort to forced, often late, but not always proportional restrictions of human rights. And then we receive the situation, when established practices powered by extended authority of SBU are leading to a total lawlessness. Paradoxically, it seems that the citizens of Ukraine are almost willing to voluntarily give the Government the gains, for which they struggled during the Euromaidan, — freedom of speech, freedom of peaceful assembly, freedom from discrimination. And here it is important to remember that in this war we don't just protect our territory. We also protect our values, i.e. the chosen by us model of interaction between the authorities and the people within its borders.

The prospect of winning the war and thus turn into Russia has no meaning.

And the third challenge. Ukraine is only learning to defend its citizens. And, in particular, those who live in the occupied territories - in Crimea and Donbas.

The lack of thoughtful policy as for the occupied territories now may complicate the future reintegration of these territories into Ukrainian homeland, which sooner or later will necessarily take place. We must translate Oleg Sentsov's words "My country won't leave me on my own" into practical action.

Ukraine has to send a clear signal to the people that it is fighting for them.

Therefore, our country is still in the "transit period". And it is quite dangerous. The inertia of returning to totalitarianism is in effect, which manifests itself in a variety of symptoms. Sometimes the mere irresponsible attitude of the ruling elite to the challenges plays into the hands of it.

The question whether this "energy of Euromaidan" will help making a quantum leap and getting out of the "turbulent zone" — to the world remains open.

EUROMAIDAN SOS

Euromaidan SOS is an initiative created in response to the violent dispersal of peaceful student demonstration at the Maidan Nezalezhnosti (Independence Square) on November 30, 2013. During the Euromaidan event volunteers of the initiative worked in the 24-hour mode to provide legal and other assistance for persecuted protesters throughout Ukraine.

Subsequently, the initiative has begun its work aimed at registration of violations of human rights in Crimea by 30 active volunteers and in the Donbas, and launched "Let my people go" campaign for the release of the Ukrainian political prisoners, which it leads so far. The E-SOS created a unique database of victims as a result of the violent actions of the representatives of the government, what later became the ground for filing report on crimes against humanity to the International Criminal Court.

Now the E-SOS has about 30 active volunteers who join their efforts around the topics of human rights protection, in particular concerning the investigation of crimes during Euromaidan, release of political prisoners and spreading the volunteer movement.

The E-SOS continues daily to lead its page in FB - Euromaidan SOS, that still counts more than 120 thousand Favorites.

The E-SOS within the framework of “Let My People Go” campaign provides support for the families of the victims and leads cooperation with lawyers who defend the rights of the illegally persecuted Ukrainians.

The campaign is supported by a number of organizations in Ukraine and beyond. In the year 2016 the campaign cared about the fate of **17 prisoners on the territory of Russia and 27 prisoners in the occupied Crimea.**

Thanks to the work of the partners of the campaign,

the Government of Ukraine, the international community, as well as the activity of attorneys, relatives and support groups, **5 Ukrainians have already been released from prison.** They all returned to the territory of Ukraine.

In addition, activists of “OZON” Public Watchers Group monitored the meeting of the Supreme Council of Justice, which dealt with the findings of the Temporary Special Commission for the Verification of Judges. Experts analyzed **57 conclusions** of the Temporary Special Commission and provided the assessment of **44 meetings** of the High Council of Justice.

“HUMAN RIGHTS AGENDA” PLATFORM

“Human Rights Agenda” Platform is an informal coalition of human rights organizations working in the field of monitoring, analysis and development of legislation in accordance with the basic principles of human rights and fundamental freedoms.

Members of the platform are leading Ukrainian human rights organizations.

The informal coalition unites around itself over 60 human rights defenders, experts, public activists who care about issues of human rights protection.

For processing narrow topics on the basis of the Platform working groups are created, into which also experts from outside the coalition are involved.

Members of the human rights platform — HRA in 2016, worked with the following topics:

- accession of Ukraine to the International Criminal Court and the ratification of the Rome Statute
- bringing the Ukrainian criminal legislation in conformity with the international humanitarian law
- constitutional foundations of judicial reform
- amnesty for participants in the anti-terrorist operation
- the reform of law enforcement agencies
- protection of the rights of internally displaced persons and those residing on the occupied territories, etc.

International round table “The Implementation of the Norms of International Humanitarian Law and the Rome Statute of the International Criminal Court to the National Legislation of Ukraine.”

In 2016, the Center for Civil Liberties put into practice conducting meetings of human rights activists and experts on the issues that are the most acute challenges to the protection of human rights. Such meetings known as “human rights clubs”. In human rights clubs both experts who are members of the Human Rights Agenda and of other expert groups participate, as well as authorized persons from the public authorities.

Human rights clubs are aimed at studying a problem deeper and finding joint ways of its overcoming. By the results of these meetings experts are united in working groups for further processing of topics, jointly develop suggestions as for further improvement of the legislation, publish statements 8 human rights clubs were held on the topics that most of all needed the reaction of the human rights community, related to the protection of human rights

Basing on the results of the human rights clubs activities: there were developed and submitted concrete proposals on improving the legislation, there were created work groups to process the topics and to work out a common stand for the human rights defenders, there were published joint statements, etc.

After the Euromaidan events it has been already for the third year the Center for Civil Liberties continues its work aimed at fixing the violations of the human rights in Crimea and Donbas.

In the first place it is about serious international crimes committed in the framework of the State policy or organization policy in accordance with art. 5 of the Roman Statute of the International Criminal Court - genocide, crimes against humanity, war crimes, aggression, or crimes against peace.

Cases of murder, unlawful imprisonment, torture, raping and a number of other human rights violations in the Donbas and in Crimea can be qualified as international crimes.

There is no true peace without the establishment of Justice — that is why registering the information about violations of human rights and committed crime is very important.

CCL independently or jointly with our partners has prepared a number of reports of human rights violations and crimes committed in the occupied territories in Crimea and Donbas.

All studies have been referred to the competent authorities for the purpose of receiving the proper reaction to their results. Also some materials were handed over to the international Criminal Court as evidence of the violation of human rights and committing war crimes.

Every year after the Revolution of Dignity, November 30, “Euromaidan SOS” re-nowns “ordinary people who do extraordinary things”.

Large-scale volunteer movement became a defining response to the challenges which Ukraine had to face during Euromaidan, and later in the fight with the Russian armed aggression.

Volunteer Award of Euromaidan SOS was founded with the purpose of expressing gratitude to the people thanks to who the country withstood in the most difficult times, as well as for the popularization and support of the volunteer movement.

ADVOCACY WORK

December 20, 2016, during the day on-air of Ukrlife TV prominent Ukrainian and Russian human rights activists highlighted their support for Ildar Dadin, who openly opposed the Government of the Russian Federation. In December 2015, he was deprived of his liberty for three years. Among the peaceful actions for which he was actually imprisoned, there were single pickets in support of Ukraine, requirements to the Kremlin to stop the war in Donbas and to free the Ukrainian political prisoners.

TO BE HEARD, WE:

20 times went to press conferences and briefings (on themes concerning the issues of amendments to the legislation and reforms, the situation with the political prisoners in Russia and the Crimea, documenting human rights violations in the East of Ukraine, results of the public watching the judicial processes and peaceful gatherings, presentations of reports, statements, etc.)

124 times published information messages concerning news in the field of human rights - an urgent information about trials of political prisoners, informing about the course of the investigation of Maidan cases, reviewing findings of the Temporary Special Commission for the Verification of Judges proceedings of the International Criminal Court, the interpretation of legislation in relation to fundamental human rights

Reports have been published on the pages in social networks and distributed to the media.

20 statements were issued by CCL and in cooperation with other organizations (concerning the inadmissibility of violation of the principle of judicial independence, regarding the organization of the process of

investigation into the “Yanukovych case”, concerning priorities in the negotiations of the settlement of the armed conflict in Donbas, regarding the protection of Ukrainian political prisoners in Russia and the occupied Crimea, about 5 disadvantages of the draft of the Constitution, addressing citizens of the Netherlands with an appeal to support the European path of Ukraine, concerning March of Equality, etc.)

13 — public events in the form of round tables, open discussions and conferences. These were conducted with the active involvement of representatives of State authorities, civil society, international organizations, experts (as for Justice in the area of ATO, the implementation of the norms of international humanitarian law, the establishment of hybrid tribunals, the elimination of the problems revealed during the events of the 31.08.2015, as for the legislative aspect of the “Minsk Agreements” (discussion in Kyiv and Berlin), as for the situation of the Crimean political prisoners (Brus-

sels), public assessment of the process of judges verification, who endorsed the decision on limiting the rights of citizens during the Euromaidan, etc.) and 14 workshops in the framework of the National Human Rights NE-Conference (as for judicial reform, reform of the Ministry of Internal Affairs, the issue of the international presence in the Crimea, the liberation of political prisoners from the list of # letmypeople-go, investigation of the Maidan cases, monitoring of trials, etc.)

26 — actions of an educational nature (lectures, seminars, training sessions, interactive sessions). These were held for community activists, students and journalists. (International School of Human Rights and Public Action, lectures for the students, “what do you have in common with Gandhi and Václav Havel?”, a seminar for journalists on the features of the work of the International Criminal Court, the actions within the framework of the Human Rights Week in the regions (Uzhgorod), training for volunteers as for monitoring peaceful assembly, etc.)

In 2016, the CCL presented alternative reports on human rights violations in the Crimea and Eastern Ukraine in the International Criminal Court, to the UN Human Rights Committee and the UN Human Rights Council, the European Parliament, during the session of the PACE.

During the OSCE annual human dimension meetings (HDIM) representatives of CCL held 3 events and advocacy meetings devoted to the violation of human rights in the Donbas and Crimea, the question of the liberation of Ukrainian hostages in Russia, co-operation with Interpol, etc.

CCL works with more than 30 embassies and permanent missions of international structures in Ukraine. In addition, there was established contact with the authorities of the European Union, Asia, and North America.



Numerous resolutions and recommendations were adopted as a result of joint work of CCL and partners

Namely, it is about the following demands to the Government of Ukraine:

- To bring Ukrainian legislation in line with the international humanitarian law;
- To introduce amendments to legislation on amnesty to prevent the exemption of persons who have committed war crimes from criminal liability, as well as the elimination of the possibility to apply the amnesty to the respective investigation and trial;

- As soon as possible to ratify the Rome Statute of the International Criminal Court (item 10.1.1).

PACE resolution was adopted as a result of advocacy efforts of the Center for Civil Liberties (meeting with special speakers, special actions in the framework of the PACE, informing in working order).



THE UN OFFICIALLY CIRCULATED THE REPORT OF HUMAN RIGHTS DEFENDERS, CONCERNING SYSTEMIC VIOLATIONS OF HUMAN RIGHTS IN PARTICULAR, CRUEL ATTITUDE AND TORTURE OF PERSONS WHO WERE ILLEGALLY PLACED TO SITES OF UNFREEDOM.



Report “Survivors of Hell: the testimony of victims about unlawful places of detention in Donbas” was distributed by the Secretariat of the UNO among the members of the Security Council and the General Assembly of the United Nations. Thanks to this, human rights defenders managed to attract the attention of the world community to the crimes that are carried out on the occupied territory of Donbas (Donetsk and Luhansk oblast of Ukraine).

The report issued by a coalition of NGOs and “Justice for the Sake of Peace in the Donbas” initiatives. CCL participated in the preparation of the report and carried out advocacy of its results among international organizations and institutions.

DESIGNED DRAFT BILL THAT INTRODUCES THE CONCEPT OF “CRIMES AGAINST HUMANITY” INTO THE CRIMINAL CODE AND BRINGS THE NOTION OF WAR CRIMES IN ACCORDANCE WITH INTERNATIONAL HUMANITARIAN LAW



To the development of the Bill there were involved the best Ukrainian and international experts in this field, as well as the Bill has received favorable reviews and support of a number of international organizations including the International Committee of the Red Cross, Parliamentarians for Global Actions, Coalition for International Criminal Court, etc.

CREATED LEGISLATIVE CONDITIONS FOR THE RATIFICATION OF THE ROME STATUTE OF THE INTERNATIONAL CRIMINAL COURT



Center for Civil Liberties leads campaign for full accession of Ukraine to the International Criminal Court from 2013 onward. By the Law of Ukraine “On Amendments to the Constitution of Ukraine (as for Justice) of June 2, 2016 amendments were applied to the article. 124 of the Constitution of Ukraine, which create

legislative conditions for the ratification of the Rome Statute of the International Criminal Court. (However, this provision shall take effect after three years from the date of entry into force of other amendments to the Constitution, what repeatedly has been subject to criticism from human rights organizations).

Center for Civil Liberties is fighting for the release of all prisoners

held on occupied Donbas. In particular, CCL, in anticipation of the meeting of the Norman four in Munich launched an international online campaign aimed at the fulfillment of the paragraph on the release of prisoners - #FreeDonbasHostages. Among civilian prisoners in whose defense Center for Civil Liberties stepped out there was also Maria Varfolomeieva, who on 17 March 2016 was liberated.

ALSO IN 2017, THERE WERE RELEASED UKRAINIAN ILLEGALLY SENTENCED PRISONERS:

- journalist **Kotsaba Maxim** – was recognized by Amnesty International as a “prisoner of conscience”
- Russian citizen **Anastasia Leonova**.

Center for Civil Liberties stepped out in the protection of both prisoners, volunteers of “OZON” Public Watchers Group carried out supervision over the judicial trials.
