“I would like to draw attention to the objectives the civil society in Ukraine faces in the fifth year after the Maidan events.

After the Revolution of Dignity, there was no restart of the political system and change of elites. This explains a lot. In particular, the half-hearted nature and the incompleteness of the reforms initiated. The power as a walker balances between the need to make radical changes and the desire to maintain control in the periodic election cycles. With each passing year, the pace of reform was reduced. But before the elections it is hard to expect any breakthrough.

The situation is complicated by the new challenges faced by Ukraine. One of them is the war.

The authorities use the rhetoric of “fighting Russian aggression” for disproportionate restrictions on human rights. Due to this rhetoric, such restrictions are supported by a large part of society. Radical groups are starting to appear. Political parties that can withstand it are still at the formation stage. Therefore, in such circumstances, maintaining the overall framework of European values is a task for civil society.

In addition, an offensive against the very civil society began, the first signs of which were discrediting campaigns and various legislative initiatives

on compulsory e-declarations, foreign agents, etc. The number of physical assaults on civil activists in the regions is increasing. Given the weakness of state institutions, the general increase in tolerance of the society to violence in connection with the war and the nexus between law enforcement bodies and local corruption elites, it is easy to predict that the Kateryna Gandziuk list will be replenished. It is time to work on building a collective security system.

Post-Maidan civil society is quite strong. Volunteers and CSOs enjoy the highest levels of trust compared to state and other public institutions. But civil society in Ukraine is scattered. It works on its narrow themes and solves local tasks. There are no ambitions for participating in discussions on the socio-political life of the country. There are no sites for joint discussions other than expert ones. Consequently, civil society has not developed a consolidated position, it does not enter into a dialogue with the authorities to promote the civil agenda. A vivid example of this state of affairs was the rather slack mobilization of civil society in response to the introduction of an obligation for anti-corruption activists to submit electronic declarations.

Ukraine is once again undergoing a critical test for the maturity of democracy.

We cannot afford to fail. Therefore, civil society must become a full-fledged participant in political life in the country; overcome fragmentation, build an ecosystem around the country, create communication and mobilization channels and formulate civic agenda. And provide the necessary energy for the country's movement in the vector that was defined by the Revolution of Dignity.

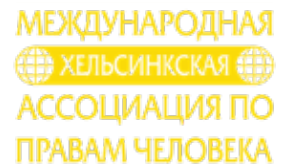

2.2. Organizational development of the Center for Civil Liberties

The CCL started active work towards strengthening its organizational capacity. To this end, in 2018, the General Meeting of the organization took place, during which amendments to the Statute were adopted and a new Board was elected. In accordance with the changes introduced in the CCL, a new collegial body, the Supervisory Board, assumed the role of the auditor. Thus, the NGO “Center for Civil Liberties” joined new people who were included in the newly elected bodies, and also became members according to the

submitted applications.

In addition, in order to differentiate between strategic direction and process management, the post of an executive director was introduced. Oleksandra Matviichuk was elected a Chairperson of the Board, and Oleksandra Romantsova became the Executive Director.

Also, the members of the Center for Civil Liberties team held a number of special trainings and field sessions on planning activities and improving professional skills in order to enhance the effectiveness of the organization.

3.1. Activities of the Human Rights Agenda Platform

The Center for Civil Liberties coordinates the activities of the informal coalition of human rights organizations working in the field of monitoring, analysis and drafting of legislation in accordance with the basic principles of human rights and fundamental freedoms – the Human Rights Agenda Platform (hereinafter HRA).

The coalition's members are leading Ukrainian human rights organizations.

The HRA unites human rights defenders, experts, public activists, who are

concerned by the issues of human rights protection, creates working groups on legislation, conducts advocacy campaigns, makes statements against the disproportionate

restrictions to human rights, organizes platforms for discussing human rights issues, promotes human rights.

Human rights defenders affected by war crimes and families of political prisoners require to refer the draft law on war crimes to the Parliament.



IN 2018 MEMBERS OF THE HRA WORKED ON TOPICS RELATED TO:

- monitoring lawmaking activities in relation to detection of threats to human rights;
- bringing Ukrainian criminal law in line with international humanitarian law and Ukraine's accession to the International Criminal Court;
- amendments to the law to introduce an effective jury trial;
- justice in eastern Ukraine in conditions of armed aggression of the Russian Federation;
- persecution of civil society representatives.

THE HRA INITIATED A SERIES OF ADVOCACY CAMPAIGNS, AMONG WHICH ARE THE FOLLOWING:

- campaign for the adoption of the draft law "On War Criminals";
- campaigns for implementing an effective jury trial model;
- campaign for the ratification of the Rome Statute of the International Criminal Court.

CAMPAIGN FOR THE ADOPTION OF THE DRAFT LAW "ON WAR CRIMINALS"

It is held with the aim of reaching the adoption of the draft law that brings Ukrainian criminal law in line with the provisions of international humanitarian law. The draft law "On War Criminals" was drafted by the HRA Working Group, which included leading experts.

More than 20 meetings were organized with representatives of the Cabinet of Ministers of Ukraine and the Verkhovna Rada of Ukraine, as well as with international organizations, public events and promotion

actions for the urgent adoption of amendments to the legislation were held.

The event, which took place on August 29 under the building of the Cabinet of Ministers of Ukraine, attracted the greatest attention of society and mass media. Human rights defenders affected by war crimes and families of political prisoners appealed to the Prime Minister of Ukraine with a request to refer the draft law to the Parliament, since it had been awaiting the approval with the Cabinet of Ministers for more than a year.

Also, the round table "Justice in eastern Ukraine in conditions of armed aggression of the Russian Federation" should be noted, which discussed the conclusions and recommendations for strengthening the capacity to provide justice in conditions of armed aggression. For two years, a group of Ukrainian experts and NGOs conducted a study to assess the impact of armed conflict on the Ukrainian justice system, as outlined in the report. The round table was held on December 18, 2018, at the

Verkhovna Rada Committee on Legal Policy and Justice.

As a result of advocacy efforts, the draft law “On War Criminals” received widespread support from public authorities and

international organizations, among them: UN Human Rights Monitoring Mission, OSCE Office, PACE Committees, International Committee of the Red Cross, Parliamentarians for Global Action,

Global Rights Compliance, Coalition for International Criminal Court, etc. On December 20, 2018, the draft law was registered with the **Verkhovna Rada of Ukraine** (Registration Number 9438).

CAMPAIGN FOR IMPLEMENTING AN EFFECTIVE JURY TRIAL

Within the framework of the HRA, a working group of experts was formed to create legislative conditions for the functioning

of an effective model of jury trials in Ukraine.

The general concept and vision of the future jury trial was developed, a draft law

was prepared and public discussions were held.

CAMPAIGN FOR THE RATIFICATION OF THE ROME STATUTE OF THE INTERNATIONAL CRIMINAL COURT

The HRA, together with the Ukrainian Legal Advisory Group, proclaimed the re-launch of a national campaign to ratify the Rome Statute in order to make Ukraine a full member of the International Criminal Court.

In support of ratification by Ukraine of the Rome Statute, the jubilee 40th Annual Forum of Parliamentarians for Global Action and the 10th Consultative Assembly of Parliamentarians for

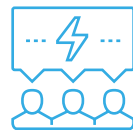

The Center for Civil Liberties initiated the development and publication of a common position of the human rights community on a number of issues. Among them are the illegal persecutions of civic activists by law enforcement agencies, the need to revoke presidential bills that disproportionately restrict freedom of association, the illegitimacy of the election process of the Ukrainian Parliament Commissioner for Human Rights, etc.

Thanks to our efforts, human rights organizations supported the statement of the R Reanimation Package of Reforms on the constitutional petition regarding e-declarations for anti-corruption activists. In addition, the arguments contained in the statements were taken into account in the Venice Commission’s findings regarding the establishment of mandatory electronic declaration.

The HRA works with the Verkhovna Rada of Ukraine, the Committees of the Verkhovna Rada of Ukraine, the Cabinet of Ministers of Ukraine, the Presidential Administration, the Office of the Prosecutor General, the Ministry of Justice of Ukraine, the Ukrainian Parliament Commissioner for Human Rights and other authorities and international organizations.

3.2. Political persecution:

CAMPAIGN AGAINST ATTACK ON UKRAINIAN CIVIL SOCIETY

Special attention of human rights activists was attracted by attack against civil society. Concerned about the current situation, we demand the illegal persecution of civic activists by law enforcement agencies to be stopped, bills that disproportionately restrict freedom of association

to be withdrawn, also we advocate the need to remove the obligation to file electronic declarations for anti-corruption activists, etc.

More than 70 representatives of NGOs, human rights activists, civic activists, journalists, lawyers and other non-indifferent citizens were joined together

with the efforts of organizations-members of the HRA. As a result, a joint **Memo-randum on the Creation of a Coalition for the Protection of Civil Society in Ukraine** was signed.

In addition, the CCL's attention is centered on cases of unlawful prosecution and attacks on activists.

Thus, for example, we are closely monitoring the investigation and trial of murder of human rights activist Iryna Nozdrovska.*

In order to increase the level of security of human rights activists and civic activists, the Center for Civil Liberties, together with the international organization “Front Line Defenders”, organized a lecture and a series of workshops, in particular on the development of scenarios and rules of conduct in the event of physical threats to civil society representatives.

* Iryna Nozdrovska disappeared on December 29 after repeated threats to her address, and on January 1, 2001 she was found dead.

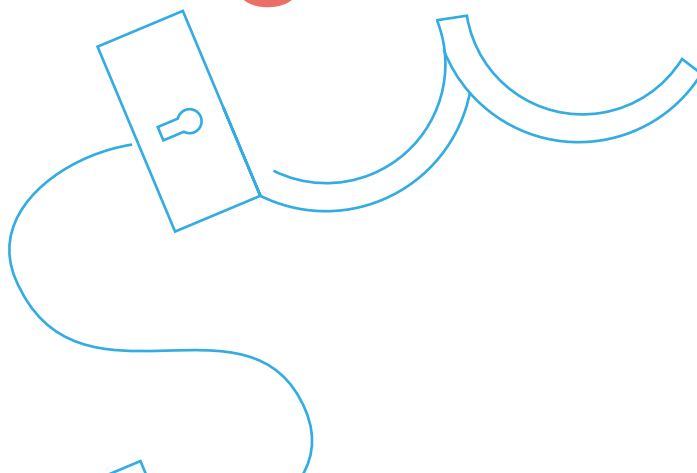
The Center for Civil Liberties, together with EuroMaidan Press and other partners, has been campaigning for the release of all Ukrainian political prisoners “#LetMyPeopleGo” for five years. By the end of 2018, 70 prisoners in Russia and in the occupied Crimea was the concern of the campaign. The total length of their imprisonment is 240 years.

Thanks to the joint work of the campaign partners, the Government of Ukraine, the international community, as well as the activities of lawyers, families and support groups 8 Ukrainians were released from prison.

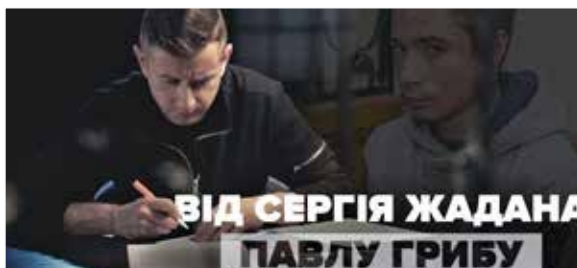

CAMPAIGN “SAVE OLEG SENTSOV”

In response to the hunger strike, announced by the illegally sentenced director Oleg Sentsov, another campaign was launched to protect the Ukrainian political prisoners - #SaveOlegSentsov.

An incredible number of activists and non-indifferent people joined it. Thanks to groups of people from 40 countries, it was possible to organize global actions, which took place almost simultaneously in different countries of the world. A whole network of adherents of the campaign held thousands of events in their cities, including screenings, promotions, pickets, demonstrations and flash mobs.

The screening of the documentary film “The Process: The Russian State Against Oleg Sentsov” was



organized in more than 50 cities of different countries.

Famous actors, directors and other artists expressed their solidarity with the illegally imprisoned director Oleg Sentsov during a variety of cultural events. The mayor of Paris, Anna Hidalgo, devoted the contemporary all-night art festival “Nuit Blanche” to him.

For these actions, top politicians had to react publicly, including the Secretary General of the Council of Europe, the President of France, the German Chancellor, the President of the Council of the EU and other public figures.

Under the influence of the campaign, it was possible to unite the requirements to release all political prisoners in the Russian Federation and civilian and military prisoners held in the basements of the Donbas.

One of the intermediate successes is the fact that the President of Ukraine supported the establishment of an advisory coordination council, a special structure that should be engaged in developing a proactive strategy of Ukraine in the release of political prisoners



and coordinating the efforts of various authorities. Creating such a body was one of the requirements of the #SaveOlegSentsov Global Campaign.

The Center for Civil Liberties also initiated a series of measures aimed at blocking the actions of the Russian Federation in the Parliamentary Assembly of the Council of Europe, which were intended to prevent the continuation of sanctions. In particular, the #SaveCouncilEurope! online promotion took place.

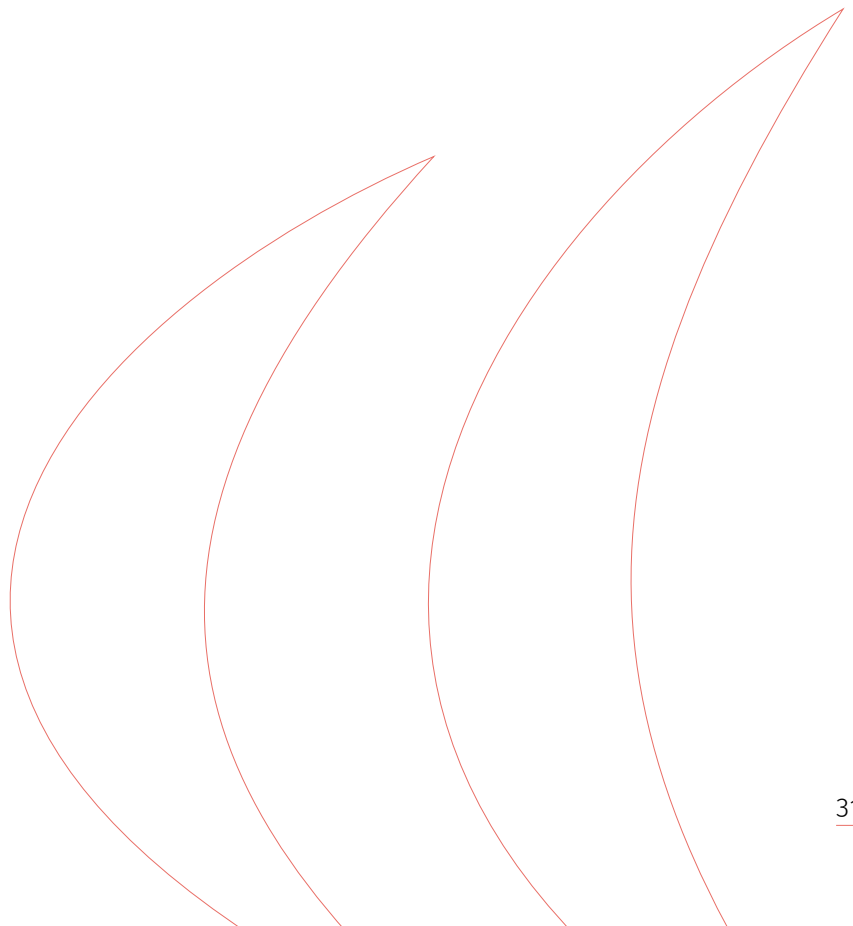

4. CIVIC CONTROL. THE OZON CIVIC MONITORING GROUP



The OZON Civic Monitoring Group is a voluntary association of active citizens exercising civic control over public authorities, as well as key processes that take place in the clash between society and the state, in particular during peaceful gatherings and trials.

The OZON Civic Monitoring Group is a member of the International Observers Network (ION) of the OSCE region.

Public observers always remain an independent party and consider their task to fix events occurring against peaceful gatherings and violations during litigation. The data are analyzed for compliance with national legislation and international standards.

The OZON volunteer can be identified by a yellow vest and a certificate stating that he/she acts as a public observer.

In total, more than 60 volunteers from Kyiv and other cities of Ukraine participated in monitoring during 2018.

In addition, a program of internship in the field of civic control began, 5 participants were selected and successfully trained at the office of the Center for Civil Liberties.





Kyiv School of Human Rights launched a special course on monitoring meetings with a higher degree of conflict. It was attended by **40** participants, **13** of them received certificates of successful completion.

The OZON group develops and provides representatives of public authorities with recommendations on the issues of ensuring freedom of peaceful assembly in Ukraine, and also cooperates with international organizations for the advocacy of these issues.



5. PARTICIPATION IN RESEARCH AND MONITORING

The CCL, together with its partners, prepared a number of reports on human rights violations, in particular freedom of peaceful assembly in Ukraine, the right to a fair trial under the conditions of the occupation of the Donbas, as well as reports on human rights violations and crimes committed in conditions of armed conflict and Russian occupation in eastern Ukraine and in the Crimea.

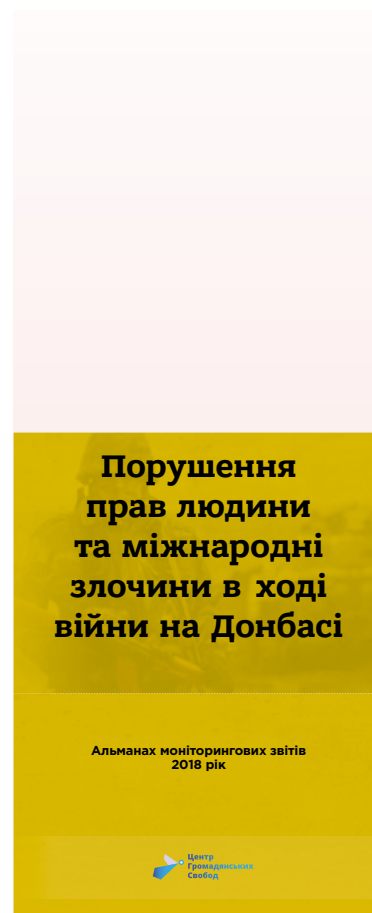

One of the priority areas for the CCL is human rights education.

To this end, the Kyiv School of Human Rights and Democracy (hereinafter - the School) was created.

Within the framework of the School there are open lectures, trainings, discussions and other

educational activities.

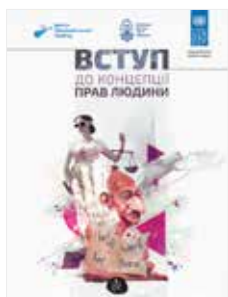
Regular training started, which consists of a multi-level program. 8 introductory human rights courses (Degree I) in Kyiv and 6 in other cities were held, as well as 1 two-day “Basic Human Rights Course” (Degree II).

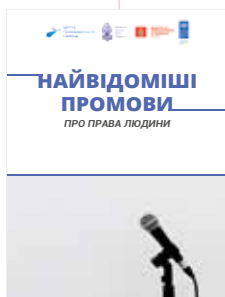

During the year more than 1000 residents of Kyiv participated in the educational events of the CCL.

KYIV HUMAN RIGHTS HUB

Kyiv Human Rights Hub started its work to support existing and create new human rights and civil initiatives. Human rights and civil society organizations, associations, as well as informal coalitions use the Hub’s capabilities for carrying out their own events.

And a number of other organizations such as the

Bereh NGO and others under the auspices of the CCL, had an opportunity to study, obtain consultancy on organizational issues, including issues related to the registration of NGOs, as well as support for working meetings, strategic sessions and planning advocacy strategies of the national and international levels.

HUMAN RIGHTS WEEKENDS

We continued the tradition of Human Rights Weekends in the regions and held 8 such human rights festivals in Kharkiv, Rivne, Cherkasy, Mykolayiv, Kherson, Odesa, Kamyanets (Dnipropetrovsk Oblast) and Lviv.

The Human Rights Weekend is a multi-day human rights festival dedicated to developing awareness of human rights and encouraging the widest possible range of people for human rights activism.

6.2. Specific activities of the Center for Civil Liberties

NATIONAL HUMAN RIGHTS NONCONFERENCE

The Center for Civil Liberties aims to form an all-Ukrainian platform for discussing the current challenges related to human rights protection in Ukraine and in the world. Thus, for the third year in a row, the National Human Rights NONconference is taking place on the anniversary of the adoption of the Universal Declaration of Human Rights.

More than 20 workshops worked during the last NONconference. The participants discussed how to solve topical human rights issues related to places of custody, the problems of people living with HIV, the problems of IDPs, the ratification of the Rome Statute, the rights of people in Crimea, the jury in Ukraine, etc. The NONconference started with the

panel discussion “The 70th Anniversary of the Universal Declaration of Human Rights: Modern Challenges for Human Rights in Ukraine and the World”, which was attended by the Deputy Head of the UN Human Rights Monitoring Mission to Ukraine Benjamin Moreau, human rights activists, dissidents and experts.

The NONconference was attended by about 400 human rights activists, civic activists, journalists, representatives of public authorities, as well as international structures and listeners from Kyiv and regions.

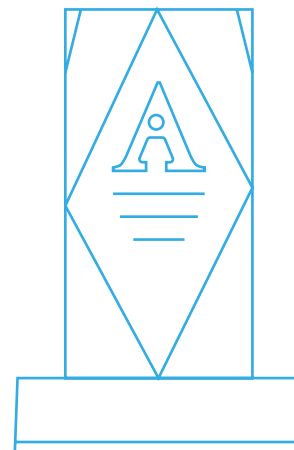

course for judges and lawyers on human rights issues, and is also a monitor of the National Preventive Mechanism.





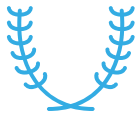

For the fifth year in a row, November 30, the Euro-aidan SOS initiative defines “ordinary people who make extraordinary things”. The Euromaidan SOS Volunteer Award is founded to promote and support the volunteer movement in Ukraine.

130 volunteers from across the country and from abroad were nominated in 2018. Many volunteers help the army or victims of the war and occupation of the Crimea. But there are more nominees who devote themselves to animal protection, education, child support, cultural enlightenment or the development of democracy.

(a US citizen), who built an orphanage in Mizhhiria, took care of a shelter for animals, assisted the victims of Russian bombardment and took out wounded soldiers.



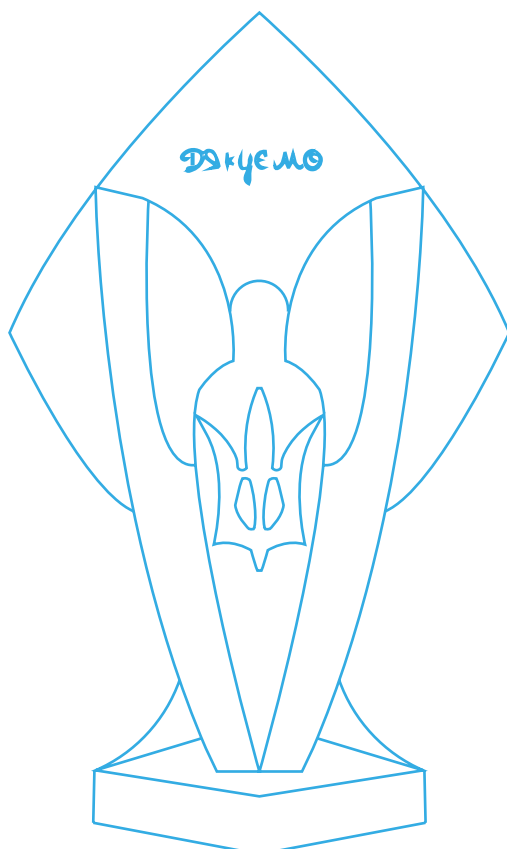

The Euromaidan SOS Volunteer Award also became a prize winner. The Ukrainian Volunteer Service and the UNV Online Volunteering service conducted a national competition for best practices in the organization of volunteer management and our initiative was rewarded.



7. INTERNATIONAL ADVOCACY





For many years we have systematically been working on solutions to human rights violations through the tools provided by international institutions and mechanisms.

The Center for Civil Liberties coordinates international advocacy in the Coalition “Justice for Peace in the Donbass”.

We work on continuous informing the Council of

Europe, OSCE, UN, European Parliament and PACE bodies and cooperate with the International Criminal Court.

The result of this work is repeatedly adopted resolutions and recommendations addressed to the Government of Ukraine, the Russian Federation and the international community.

Meeting in the framework of the annual OSCE Human Dimension Meeting on the human rights situation in gray areas, in particular in the occupied Ukrainian territories.



The key issues we worked on over the past year were the following:

- Introduction of the human rights context to the so-called Minsk Process;
- Release of Oleg Sentsov and all other Ukrainian political prisoners in Russia, as well as captives and hostages held in the ORDLO;
- bringing Ukrainian legislation in line with international humanitarian law.

In order to inform representatives of diplomatic missions and international organizations about the human rights situation in the Donbas, the Center for Civil Liberties organized a round table: “Results of the monitoring of human rights violations and international crimes and the social and humanitarian situation of the population in the occupied territory of the Donbas”.

During the event, members of the Coalition “Justice for Peace on the Donbass” presented reports.

22 representations of foreign embassies in Ukraine and international organizations were invited: International Committee of the Red Cross, European Commission in Ukraine, United Nations Human Rights Monitoring Mission, European Union Advisory Mission, OSCE Special Monitoring Mission in Ukraine, etc.

THE DRAFT LAW ON THE IMPLEMENTATION OF AN EFFECTIVE JURY TRIAL IN UKRAINE WAS DRAFTED.

The Draft Law of Ukraine “On Amendments to Certain Legislative Acts of Ukraine on the Introduction of the Jury” was developed by the working group of the Human Rights Agenda Platform. The adoption of the draft law will start a wave of genuine changes to the judicial system in Ukraine.

The adopted document contains requirements for the admission of doctors, humanitarian missions, the International Committee of the Red Cross, etc., torture and inappropriate conditions of detention are condemned. The Resolution adopted for the first time brought together the issue of political prisoners and captives in the Donbas as the unified common requirement for the Russian Federation.



THE PETITION ON THE WEBSITE OF THE WHITE HOUSE – AN APPEAL TO THE PRESIDENT OF THE UNITED STATES DEMANDING THAT EVERYTHING BE DONE FOR THE RELEASE OF OLEG SENTSOV AND ALL UKRAINIAN POLITICAL PRISONERS – GAINED 100 THOUSAND VOTES.

ON JUNE 14, 2018, THE RESOLUTION WAS ADOPTED BY THE EUROPEAN PARLIAMENT DEMANDING THE RELEASE OF OLEG SENTSOV AND ALL OTHER UKRAINIAN POLITICAL PRISONERS HELD IN THE RUSSIAN FEDERATION AND THE CRIMEA.

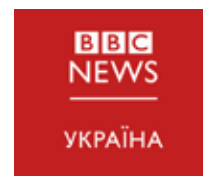
